The Ndwedwe Municipality subscribes to the Preferential Procurement Framework Act, Act 5 of 2000, new **80/20** Preference Points System will apply in terms of the Preferential Procurement Regulation 2017 (B-BBEE Status Level of Contribution) - an original or certified copy of the Certificate is required. In case of EME's bidder may submit an original **SWORN** Affidavit signed by a commissioner of oaths to claim Preference Points.

Bids shall be valid for a period of **120 days**. The Ndwedwe Local Municipality does not bind itself to accepting the lowest, or any bid, either wholly or in part or give any reason for such action,
